

**Aspen Speedos Board Meeting  
April 13, 2005**

Registrations- 2005: It looks like we may have about 10-12 new swimmers this season. We really won't know until we get all the paper work in. Greg has still not received all the forms from returning swimmers and encourages everyone to get them in as soon as possible.

Zone 4 Meeting: Laura filled us in on the Zone 4 meeting. The scheduling was the main topic and the fact that Sopris had chosen the same weekend as Aspen to hold their meet was discussed. Aspen had lots of support. Sopris was told that they would not have a sanctioned meet if they were to hold it the same dates as ours. No one was there representing Sopris, however within a few days they announced that they would hold their meet the weekend of June 17<sup>th</sup>. Because of finances, the committee has suspended the reimbursement of official travel. They also have instituted stricter rules governing the payment of dues, splash fees, etc. Teams will not be allowed to compete until they have paid all their dues.
