

Aspen Speedos Board Meeting
March 18, 2004

1. Parents Meeting: -Proposed date is April 22nd, 5:00pm. Laura will check to see if we can hold it at the ARC in the room next to the ice rink. We will try to sell caps, suits, sweats, T-shirts and fins at the meeting. Sweats and fins can be sized and ordered at that time. Suits and hopefully caps will be there to pick up. We will advertise the meeting in school newsletters, high school bulletin board, and handouts at ARC. We will also try and set up a table at the Meltdown on April 10th at the ARC with information on the team. Scholarship contact person will be Stan Kornasiewicz. Team fee will be \$650 per swimmer.
2. New Swimmer Practices- We decided instead of a separate week the new swimmers will start on Monday May 3rd and 4th. Returning swimmers will start on Wednesday May 5th. New swimmers will be charged \$50.00 for that week- fee will go toward total cost if they join.
3. Credit Card-It was decided it would be worthwhile to let people use a charge card for team fee plus extras. Greg can run it through his business.
4. Team Fee will be \$650.
5. Registration Sheet-We discussed various items which will be listed on the 2004 team registration sheet. This will be passed out at the parents meeting.
6. Swim Parent Survival Guide- The team will purchase these pamphlets for \$1 each to give to swim parents – it has good general information.
7. Safety Officer-Archie will be listed.
8. Coaching staff update- Laura and Greg have interviewed 5-7 people. They have 1 very strong candidate we hope to hire as an assistant coach- he has strong swimming background including collegiate level and also swimming for Germany. There is also another candidate who has competitive swimming background and has taught young children. Steve, the Masters coach, will return in July and may come on board for the month as well.

9. Coaching staff meeting representative- Greg hopes that Elizabeth may take on this responsibility- duties would be attending meetings of coaches- making sure they communicate and also include dry –land training.
10. Equipment purchase coordinator- We have approx. \$3000-\$4000 worth of equipment to purchase for the team- fins, kickboards, mats, etc. Steve will talk to Victoria to see exactly what's needed and then will try and check costs with different companies.
11. Scholarship fund- \$866.00. Enough for 4 swimmers
12. Ducky Derby Credits- This summer kids will not be required to sell ducks, however if they do 80% of their sales will go towards their swim team fee. Any additional earned above this amount will go into the scholarship fund.
13. Swim Caps- Elaine is looking into possibly a new color
14. T-Shirts- Mary is ordering t-shirts to sell with the Speedos logo.
15. Suits- suits are in and will cost \$35.00 for girls and \$25.00 for boys
16. Sweats and Fins- We will have samples at the parents meeting so the correct sizes can be ordered.
17. Thrift shop- They gave the team \$1000
18. Swim Meet- no swim meet in Aspen this year
19. Practice Schedule- Greg is discussing pool times at this time. We will probably practice between 7:00am and 9:30am.
